## SSLI – State Sponsored Life Insurance National Guard Association of Illinois Militia Insurance Trust

The Illinois Department of Military Affairs approved the SSLI program for the National Guard Association of Illinois over 20 years ago. Today, there are over 5,000 members enrolled for the Group Family Term life insurance Program. 2,200 spouses are enrolled and 1,500 members continued the plan into retirement.

The most important success is the \$10,000 "New Recruit" program. Every month, 50 new recruits are taking advantage of this \$10,000 benefit. This \$10,000 "New Recruit" benefit is at no cost to the recruit for the first year of their enlistment. NGAI extends their gratitude to the Army Recruiting Command and the Air Guard personnel Chiefs for their help to bring this \$10,000 benefit to new recruits.

NGAI's family Term Life Policy is underwritten by New York Life (51 Madison Avenue, New York, NY 10010) through the Militia Insurance Trust. This is an affordable payroll deductible plan that makes coverage available to
